

Divorce

We have three Fixed Fee divorce packages depending in whether you are filing for divorce, have received divorce papers or need a checking service of your papers.

Package 1 - Petitioner/party applying

If you are filing for divorce If you are wishing to serve divorce papers on your ex-spouse, this package includes:

- One meeting with specialist family lawyer
- Preparation of divorce documentation at all stages up to finalisation
- All communication and support throughout the process

Fee £480.00 (including VAT)

Court fees (if applicable) £550.00

Total £1030.00

Payment Options You can pay in full in advance by credit/debit card, cash or PayPal in advance (a 5% discount will be given on our costs)

If you would prefer to pay in stages, you can pay:

£240 on receipt of instructions plus £550.00 Court fee payable when divorce papers are issued

£240 on submitting the Application for Decree Nisi

You may not have to pay the Court fees if your income is within certain limits.

Please Note the package does not include the following-

- Copy marriage certificate
- Enquiry Agent fees should the divorce papers need to be served on your spouse, deemed service or bailiff service. We charge £80.00 plus vat for the administration in relation to these applications along with the disbursement charged by the relevant agent.
- Should there be any delay either by you or your ex-spouse, unforeseen events or contested divorce. In the unlikely event that this occurs we will give you an estimate of extra costs.

Package 2 - Respondent/Party receiving papers

If your ex-spouse has filed for divorce If you have received divorce papers from your ex-spouse or wish to respond to their intention to file for divorce, this package includes:

- One meeting with specialist family lawyer
- Completion of relevant Court papers
- All communication and support throughout the process

Fixed Fee £228.00 (including VAT)

This package must be paid in full, in advance by credit/debit card, cash or PayPal in advance

Please Note the package does not include the following:

- Should there be any delay either by you or your ex-spouse, unforeseen events or contested divorce.

In the unlikely event that this occurs we will give you an estimate of extra costs.

Package 3 - Divorce document checking service

We offer a service of providing and checking divorce papers. We will forward the divorce papers to you once you have completed the online application with your personal details and payment method i.e. debit/credit card or PayPal.

The papers can be sent to you via e-mail and it is also possible for you to attend the office in person to provide us with your personal details and collect your divorce pack. You will then complete the papers in person and return these back to us for checking. You must return the papers along with your marriage certificate so that the papers can be fully checked to ensure they will not be returned by the Court due to being completed insufficiently or incorrectly completed.

This service does not include any legal advice and is purely a checking service similar to that of a passport application.

This does not include any queries or assistance in relation to the Court Fee Remission Form (to be exempt from paying the Court fee). We do offer this service at an additional fee explained below.

We aim to provide you with the divorce papers within 24 hours of cleared funds and once we receive the completed forms for checking, we return these back to you within 48 hours upon receipt (not including weekends and bank holidays).
